### Cookies Policy

#### 1. Introduction

- 1.1 Our website uses cookies.
- 1.2 Not all these cookies are strictly necessary for the provision of [www.octasis.com](http://www.octasis.com) website and services, we will ask you to consent to our use of cookies when you first visit our website.

#### 2. About cookies

- 2.1 A cookie is a file containing an identifier (a string of letters and numbers) that is sent by a web server to a web browser and is stored by the browser. The identifier is then sent back to the server each time the browser requests a page from the server.
- 2.2 Cookies may be either "persistent" cookies or "session" cookies: a persistent cookie will be stored by a web browser and will remain valid until its set expiry date, unless deleted by the user before the expiry date; a session cookie, on the other hand, will expire at the end of the user session, when the web browser is closed.
- 2.3 Cookies do not typically contain any information that personally identifies a user, but personal information that we store about you may be linked to the information stored in and obtained from cookies.

#### 3. Cookies that we use

- 3.1 We use cookies for the following purposes:
  - (a) Authentication - we use cookies to identify you when you visit our website and as you navigate our website cookies used for this purpose are: "*SID / HSID*", "*pm\_sess*", "*YSC*" cookies;
  - (b) Status - we use cookies to help us to determine if you are logged into our website cookies used for this purpose is: "*NID*";
  - (c) Shopping cart - we use cookies to maintain the state of your shopping cart as you navigate our website cookies used for this purpose are: "*pm\_sess*", "*YSC*";
  - (d) Personalisation - we use cookies to store information about your preferences and to personalise our website for you cookies used for this purpose are: "*VISITOR\_INFO1\_LIVE*", "*NID*";
  - (e) Security - we use cookies [as an element of the security measures used to protect user accounts, including preventing fraudulent use of login credentials, and to protect our website and services generally cookies used for this purpose are; "*SID*" and "*HSID*";

- (f) Advertising - we use cookies [to help us to display advertisements that will be relevant to your cookies used for this purpose are: “IDE”, “NID” and “ANID”];
- (g) Analysis - we use cookies [to help us to analyse the use and performance of our website and services cookies used for this purpose is: “\_ga”];
- (h) Cookies consent - we use cookies to store your preferences in relation to the use of cookies more generally Cookies used for this purpose is;”NID”.

#### 4. Cookies used by our service providers

- 4.1 Our service providers use cookies and those cookies may be stored on your computer when you visit our website.
- 4.2 We use Google Analytics to analyse the use of our website. Google Analytics gathers information about website use by means of cookies. The information gathered relating to our website is used to create reports about the use of our website. Google's privacy policy is available at: <https://policies.google.com/privacy>.
- 4.3 We publish Google AdSense interest-based advertisements on our website. These are tailored by Google to reflect your interests. To determine your interests, Google will track your behaviour on our website and on other websites across the web using cookies. OR [We publish Google AdSense advertisements on our website. To determine your interests, Google will track your behaviour on our website and on other websites across the web using cookies. This behaviour tracking allows Google to tailor the advertisements that you see on other websites to reflect your interests however we do not publish interest-based advertisements on our website.
